The position will lead a proactive business development strategy and implement a formal project management process codifying the organization's responses to government grants and other RFP opportunities.

This position will be sector and policy area agnostic, with an initial priority focus on the sectors of transportation and environment.

This position will serve as a member of Equiticity's Senior Leadership Team.

- Lead impactful research projects, focused on better understanding the severity of racialized inequities, improving the equitable distribution of resources, and informing transformative policies.
- Lead consulting projects and services with a range of clients and partners across the US and around the world.
- Lead a proactive business development strategy, identifying potential teaming partners, as well
  as grant opportunities and other RFPs issued by government agencies, foundations, and
  corporations.
- Lead the writing and project management process for responding to research- and consulting-related government grants and other RFP opportunities, at the federal, regional, state, and local levels.
- Lead the dissemination and marketing of Equiticity's research products and consulting services.

- Support the drafting of policy frameworks and related advocacy and policy positions for public distribution.
- Represent Equiticity as needed in local, state, national, and global forums, and participate in relevant coalitions, networks, and partnerships.
- Collaborate with the members of Equiticity's Senior Leadership Team, developing internal
  partnerships across our pillars of research, programs, advocacy, Community Mobility Rituals, and
